1) The Continuation / Extension of Affiliation is issued for the Academic Year 2021-22 subject to the permission of Central Council of Ayurved and Unani, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation will be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the Central Council of Ayurved and Unani, New Delhi/Govt. of India/Department of AYUSH, New Delhi.

2) The admission shall be done only through the Competent Authorities.
